#### **AGENDA ITEMS**

1. Public Hearing to consider ZVAR 2013-13 Arbor Terrace Ponte Vedra Memory Care Facility. Request for a Zoning Variance to Table 6.01 which limits the maximum lot coverage by all buildings for non-single family or mobile home uses within the Open Rural zone district to 20%, location of property 5125 Palm Valley Road.
