1. **Public Hearing to consider SUPMAJ 2014-06 McAvoy Animals.** Request to allow for Special Use Permit to allow for the keeping of up to 6 horses pursuant to Section 2.03.05, along with a request to allow the keeping of up to 8 chickens, 2 potbellied pigs and 2 goats, pursuant to Section 2.03.06 of the Land Development, in an RS-2 zoning district Code, located at Popolee Road.
