1. PVZVAR 2019-05 Pollock Residence. Request for a Zoning Variance to Section VIII.D of the Ponte Vedra Zoning District Regulations to allow a twenty (20') foot encroachment of the platted rear building restriction line for construction of an attached screen room, specifically located at 536 Rutile Drive.

2. PVZVAR 2019-06 Walker Residence. Request for Zoning Variance to Section III.B of the Ponte Vedra Zoning District Regulations to allow a twelve foot and six inch (12'6") encroachment of the required forty foot (40') rear yard for the construction of gazebo structure, specifically located at 534 Le Master Drive.

3. Workshop - Fence Height. The Ponte Vedra Zoning and Adjustment Board and members of the Ponte Vedra community have requested to continue the general discussion on fence height limitations in the R-1-A and R-1-B zoning districts. The purpose of the workshop is to provide direction to staff on possible amendments to the Ponte Vedra Zoning District Regulations to allow increased height allowances for fencing within rear and side yards to address a number of current violations and provide residents with increased privacy.

If a person decides to appeal any decision made by the Ponte Vedra Zoning and Adjustment Board with respect to any matter considered at the meeting or hearing, he or she will need a record of the proceedings, and for such purpose he/she may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is based.
