1. **PVZVAR 2019-07 Eaglestar Beach House Addition.** Request for a Zoning Variance to Section III.B.1 of the Ponte Vedra Zoning District Regulations to allow a reduced front yard setback of 33 feet in lieu of 40 feet for construction of an addition to the existing garage/guest house. The oceanfront property is located at 1201 Ponte Vedra Boulevard.
