AGENDA ITEMS

Presenter – Mercedes E. Harrold, Cultural Resources Coordinator

1. **Discussion on Cultural Resources that may be eligible for the *National Register of Historic Places* (NRHP).** At the February 2020 CRRB meeting, the CRRB directed staff to present cultural resources that are County owned or on County property that may be eligible for the NRHP.
2. **Appointment to Mr. McClain's unanticipated vacancy.** At the December 2019 CRRB meeting, the CRRB removed Mr. McClain from the CRRB due to absences. This created an unanticipated vacancy. The CRRB shall discuss and recommend a nominee to complete the remainder of Mr. McClain's term, which will expire on November 6, 2022.
3. **Letter of Support.** Staff is requesting that the CRRB write a letter of support. Staff would like the opportunity to apply for two Small Matching Grants from the Division of Historical Resources during the next cycle (April 1, 2020 – June 1, 2020). If approved by the Board of County Commissioners, staff would apply for (1) a grant to conduct a Historical Properties Survey of A1A (specifically from Ponte Vedra to Vilano Beach) and (2) a grant for a Cultural Resources Interpretation Program in St. Johns County.
